TO: Licensees and Registrants, API Monogram/APIQR Program

RE: 2023 Annual and Application Fees

The API Monogram/APIQR Program has worked steadily to bring more products into the licensing program, to improve the effectiveness of API audits, and to calibrate responses to clients, all while holding annual and application fees flat for nearly a decade. These efforts and others are intended to improve the program and to provide greater value to licensees and registrants. While efforts to improve the program will continue, we can no longer do it at our current rates. After careful review, we have determined that we must increase our annual and application fees. The revised fees are detailed below, and API will apply them to the 2023 Monogram and APIQR annual fees and to new applications submitted after December 31, 2022.

As mentioned above, API continually invests in improvements to the Monogram/APIQR Program to benefit licensees and registrants. A number of these investments are described below:

- Added several new product standards and specifications to the program in the areas of subsea equipment, completions, and barrier technology and implemented auditor and team member training in these new standards and specifications.
- Made improvements to audit scheduling to speed up audit assignment and provide auditors with the flexibility to set the exact audit dates directly with the licensee or registrant.
- Increased auditor observations and auditor training or "calibration" to ensure more effective audits across the entire auditor pool.
- Instituted regularly scheduled mandatory technical review sessions for Monogram/APIQR audit team reviewers to promote a more consistent methodology for reconciling audit findings with technical requirements.
- Added new team members dedicated solely to maintaining and improving the MyCerts web portal who have already implemented improvements to facilitate access, applications, communications, and audit review and will continue making improvements in the future.

API Monogram/APIQR team members are working to address the needs of the industry and can only do so with the support of program licensees and registrants.
