

GASOLINE TAXES

January 2010

Nationwide

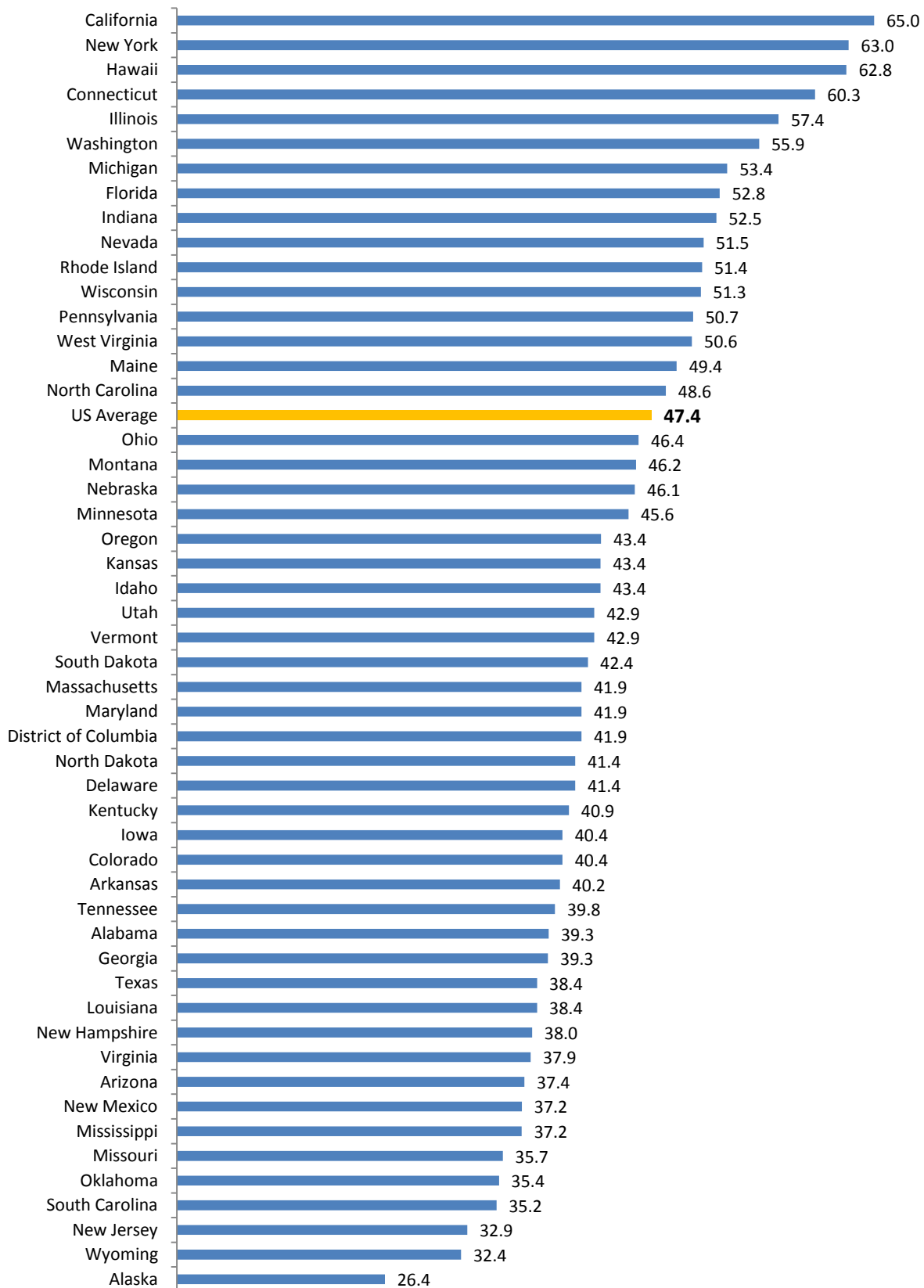
The nationwide average tax on gasoline of 47.4 remained relatively unchanged since October 2009. A summary of federal and state excise taxes and other taxes collected on gasoline is shown below. The federal tax on gasoline is 18.4 cents per gallon. The average state gasoline excise tax remained at 18.5 cents per gallon from October. Other taxes (such as applicable sales taxes, gross receipts taxes, oil inspection fees, county and local taxes, underground storage tank fees and other miscellaneous environmental fees) are approximately 10.5 cents per gallon, up from 10.4 cents the previous quarter. Adding these taxes and fees to the state excise taxes results in a volume-weighted average state and local tax of 29 cents per gallon.

DIESEL TAXES

January 2010

Nationwide

The nationwide average tax on motor diesel fuel of 52 cents per gallon remains relatively unchanged since the October 2009 study. A summary of federal and state excise taxes and other taxes collected on diesel is shown below. The federal tax on diesel is 24.4 cents per gallon. The average state diesel fuel excise tax was 19 cents per gallon. Other state and local taxes average around 8.8 cents per gallon, up from 8.5 cents per gallon the previous quarter. These other taxes include applicable sales taxes, gross receipts taxes, oil inspection fees, county and local taxes, underground storage tank fees and other miscellaneous environmental fees. Adding these taxes and fees to the state excise taxes results in an average state and local tax of 27.8 cents per gallon.
