



Would you say that things in Connecticut are going in the right direction, or have they gotten off on the wrong track?







When it comes to electricity prices here in Connecticut, do you think they are too high, too low or about right?







Voters Are Concerned About Electricity Prices In The State





■ Very concerned = Somewhat concerned = Don't know/Refused = Not very concerned = Not at all concerned



■ Electricity generators compete ■ The state government chooses ■ Don't know/Refused














