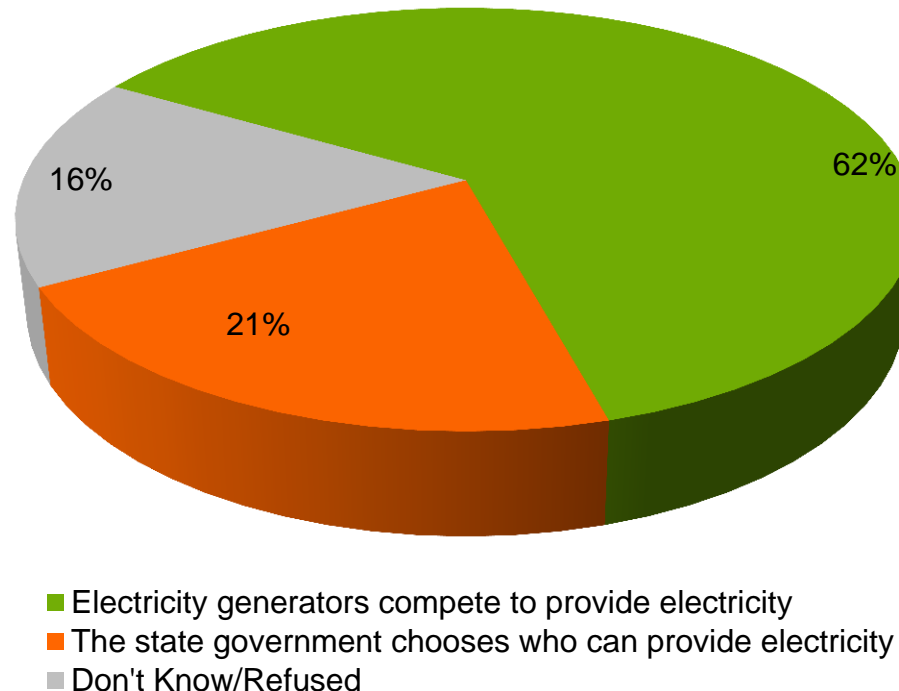

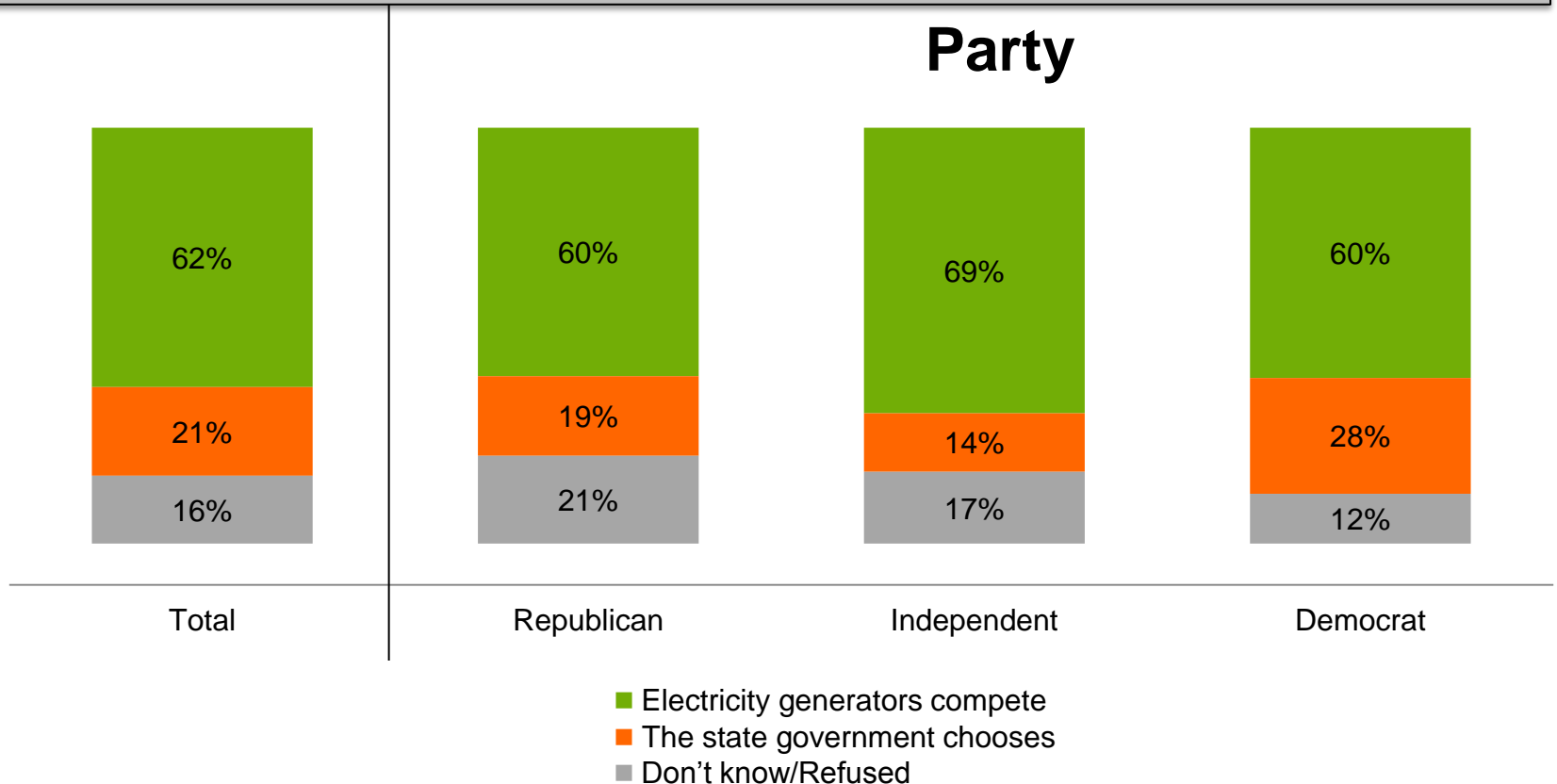

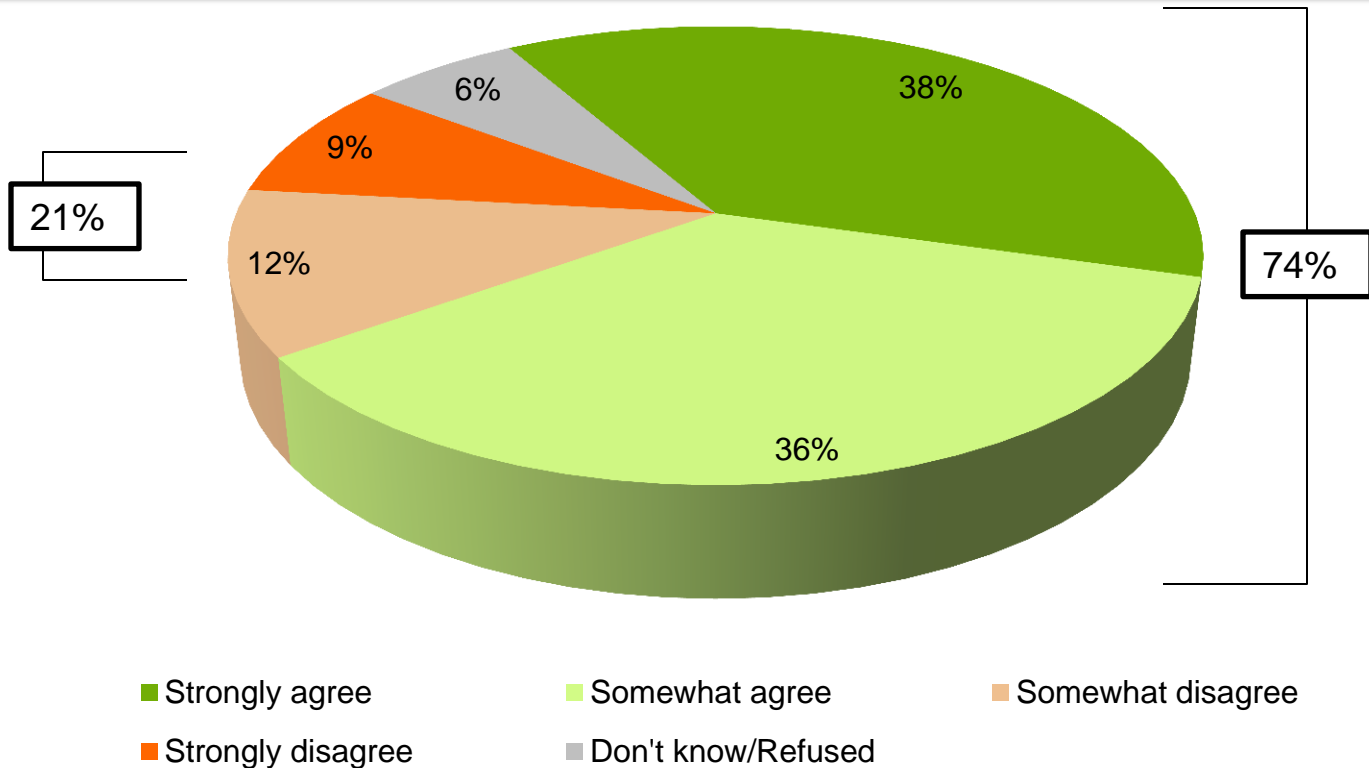

Do you agree or disagree with the following statement: The electricity market in New Jersey should be based on the marketplace, and not on particular corporations the government decides to grant money to.

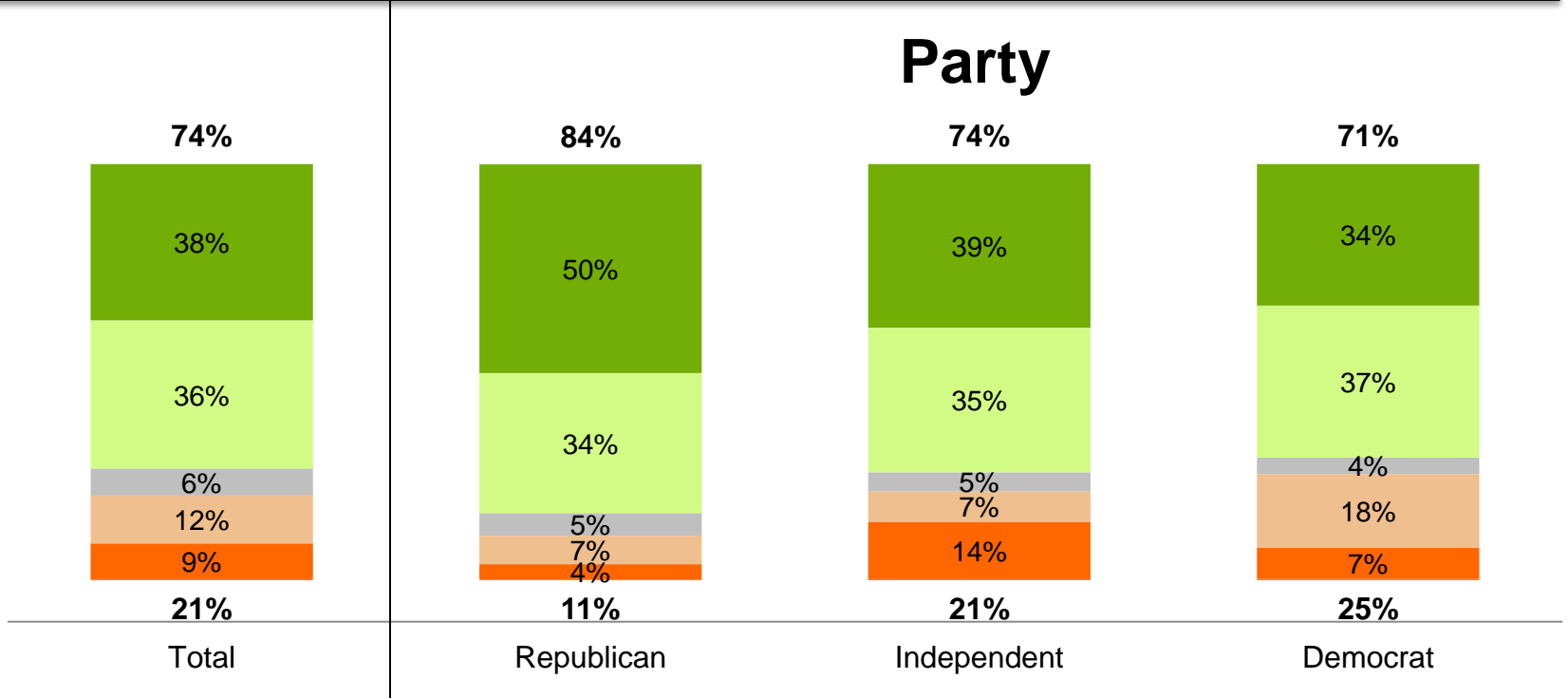

Do you agree or disagree with the following statement: The electricity market in New Jersey should be based on the marketplace, and not on particular corporations the government decides to grant money to.



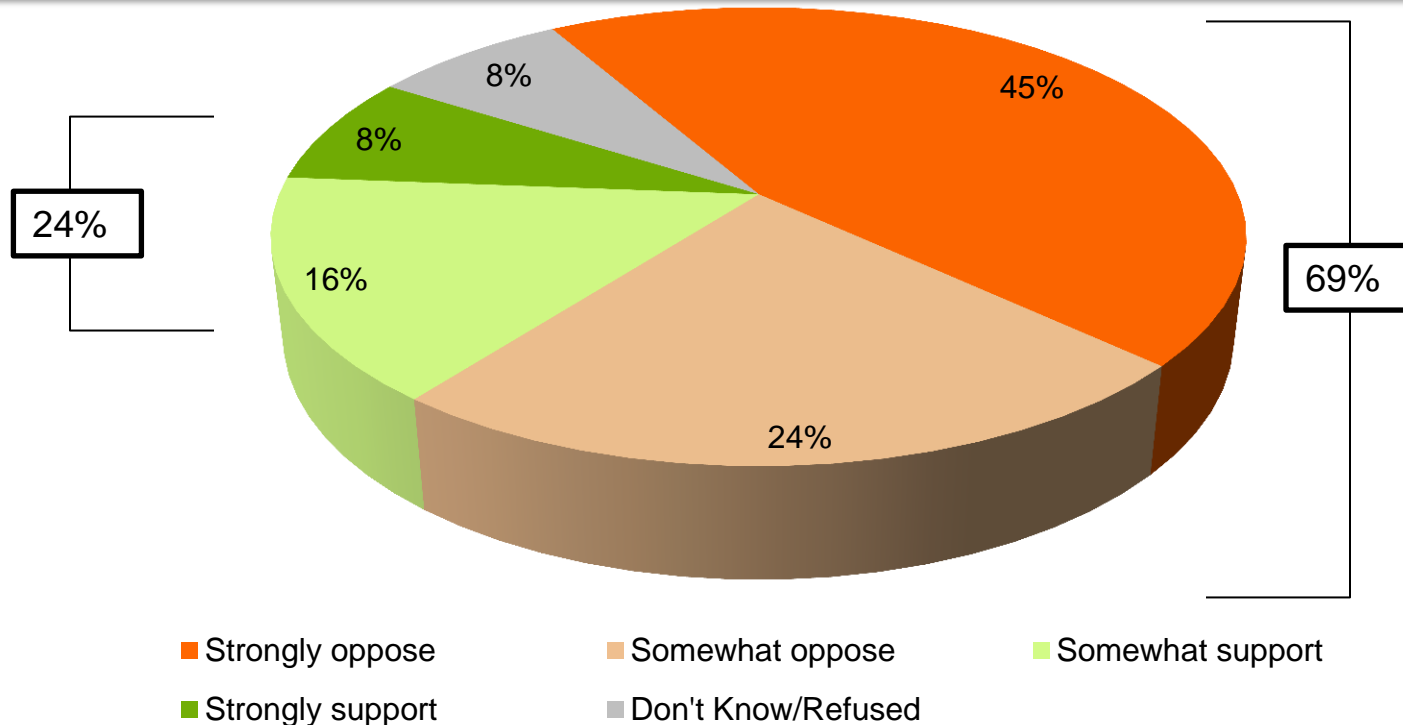

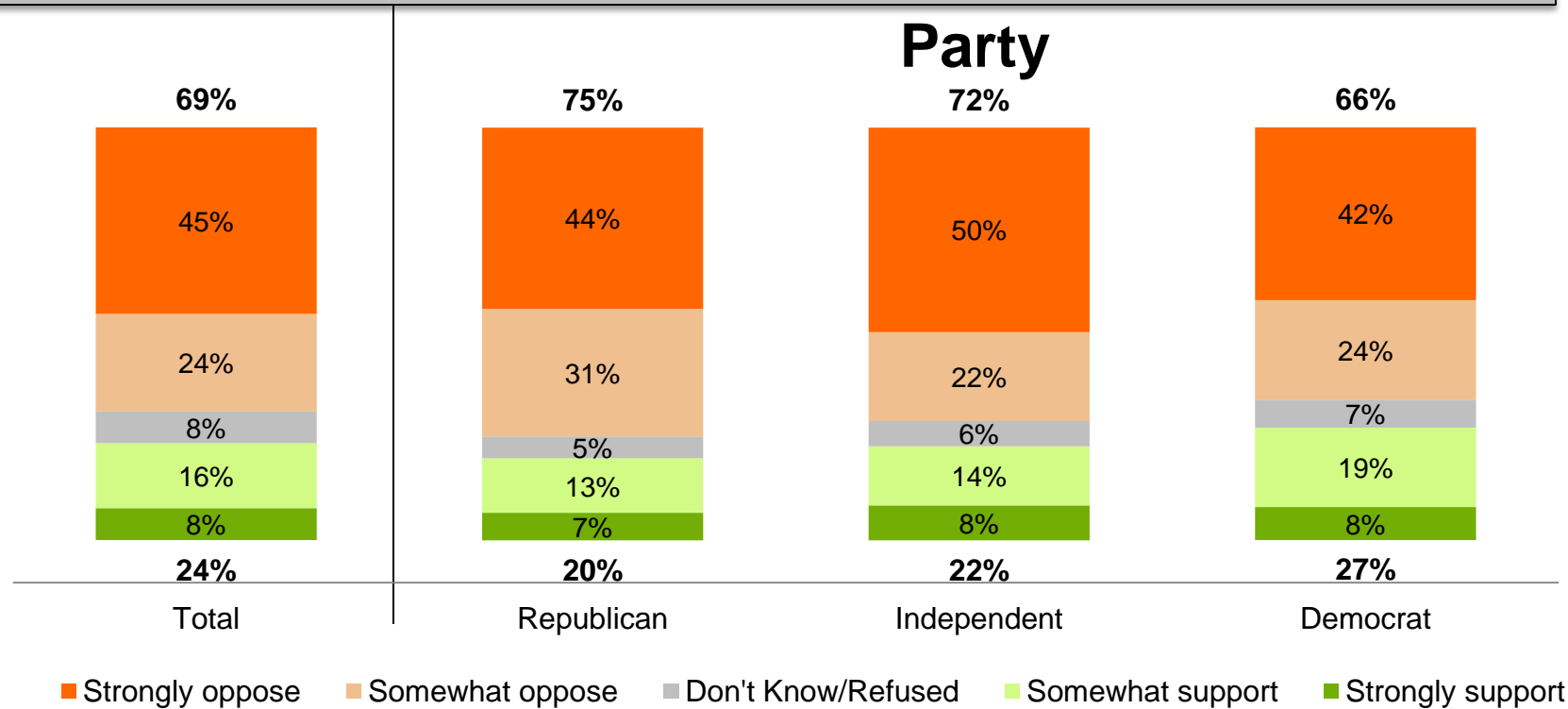
