

- Display Items: One 8'x6' exhibit booth will be made available to each exhibiting company during the conference.
- Sharing of Booths: Exhibit booth signage and listing in program will only include one company name. Cosponsoring or co-exhibiting is not permitted.
- 6. Floor Plan Layout Changes: All exhibitors should frequently review their space location and changes to neighboring booths/areas for updates. It is the exhibitor's responsibility to keep up with changes to their assigned area. API is anticipating alterations to the initial printed plan and Cannot be held responsible for changes which may alter a participating exhibitor's selection of space, or for the exhibitors that elect to be located next to you.
- 7. Subletting of Space: The exhibitor agrees not to assign, sublet or apportion space or any part thereof contracted for by the exhibitor. Exhibitors may not permit non-exhibiting company representatives to work in their booths except their direct employees or representatives.
- 8. **Promotional Piece:** One marketing piece may be provided by each Sponsor for insertion in the conference bag. 400 copies of your promotional piece must be delivered to Matthew Cunningham, c/o Westin Houston Memorial City, not before July 8th and no later than July 11th to assure inclusion. Please write "Sponsor" in bold letters on the box.

- 10.
