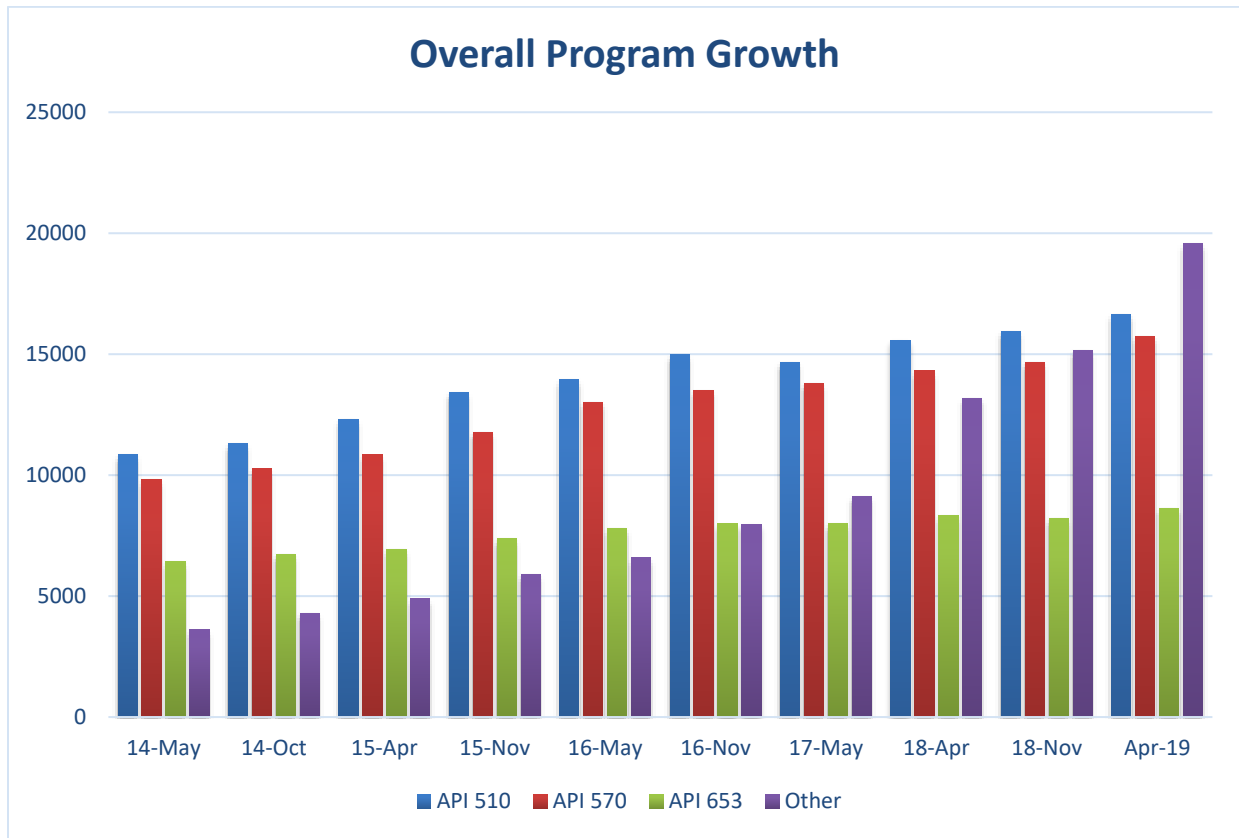

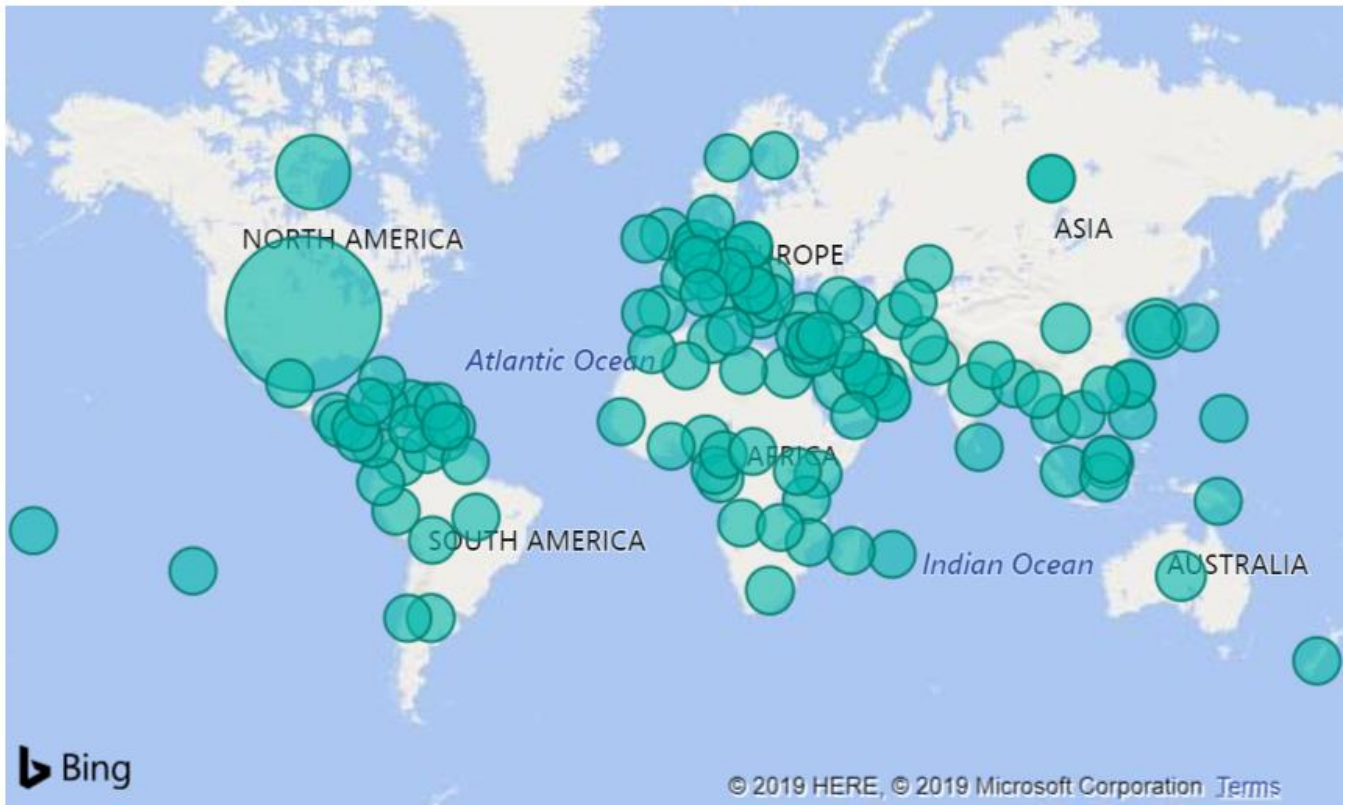

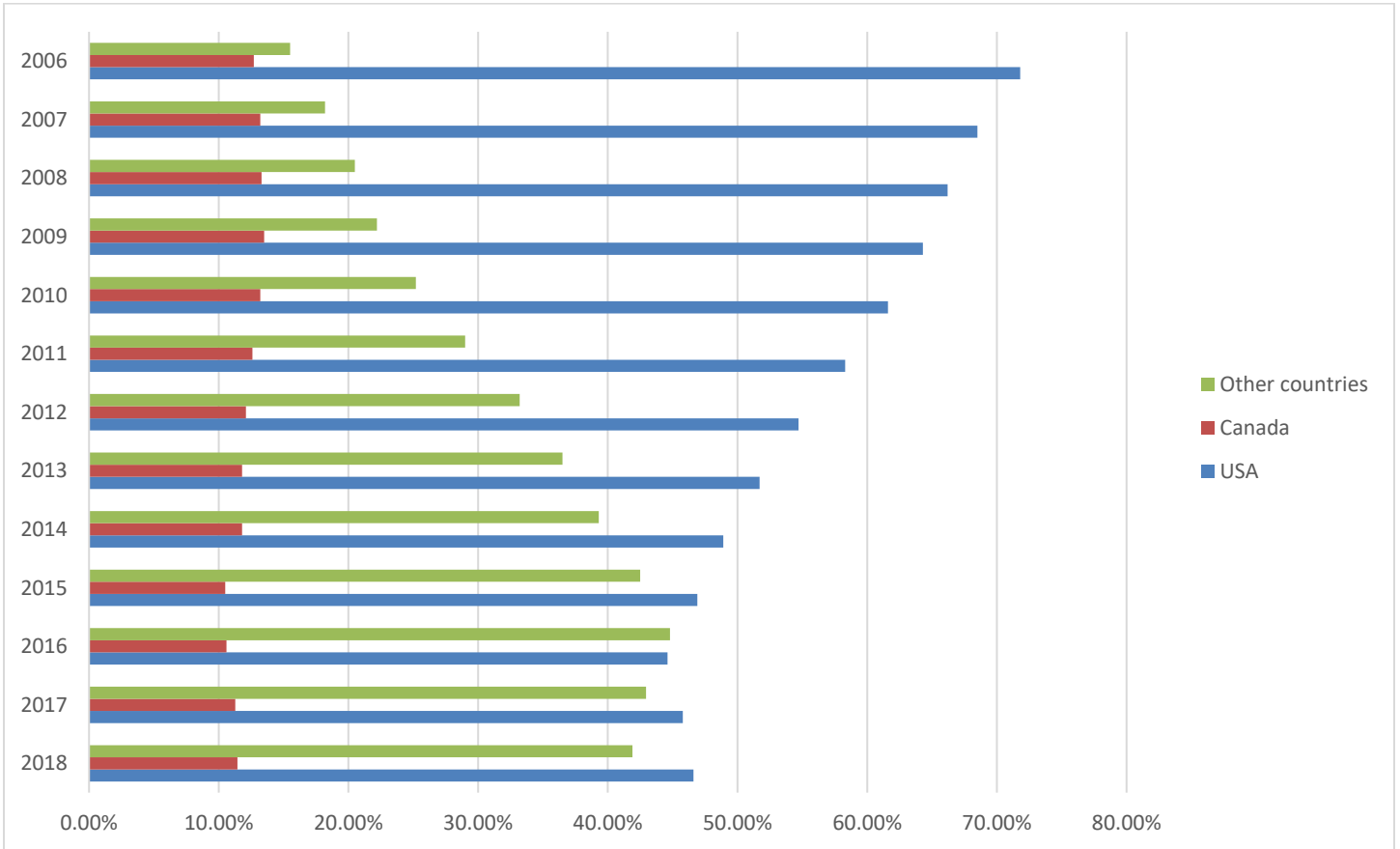

## Percentage Breakdown of Certified Inspectors

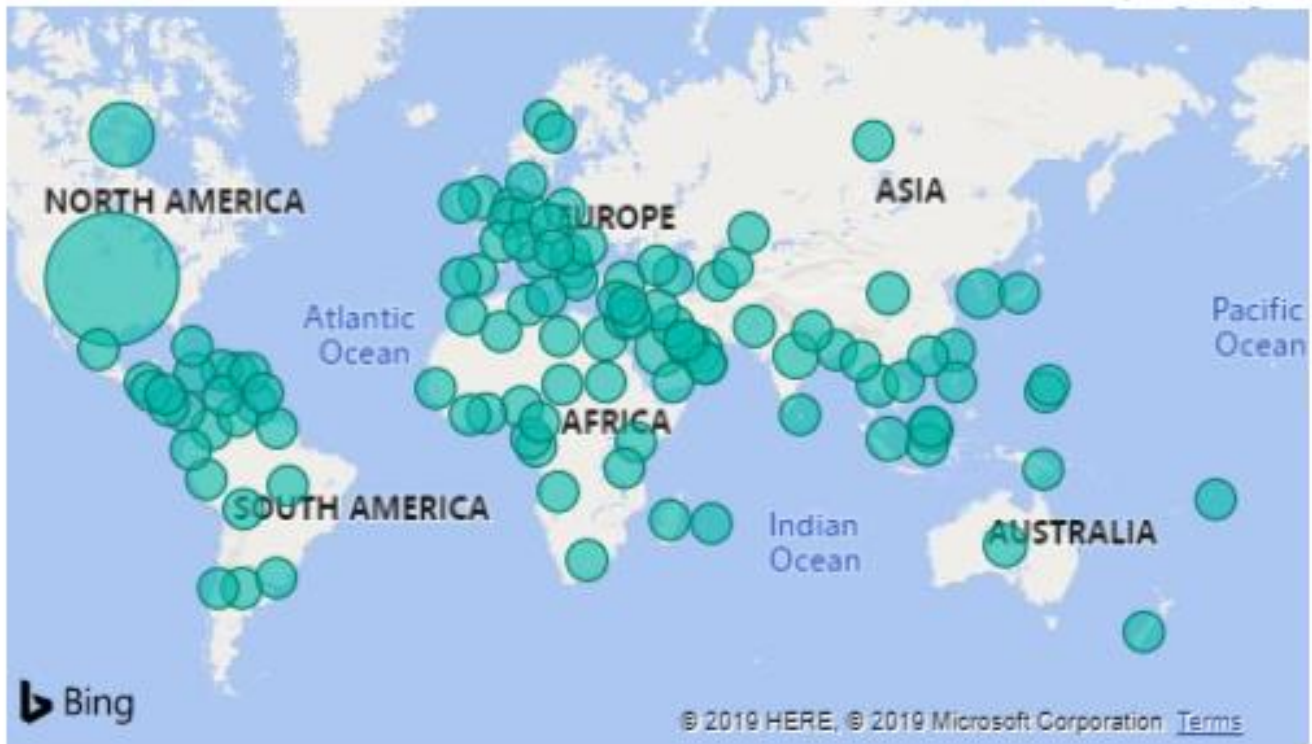

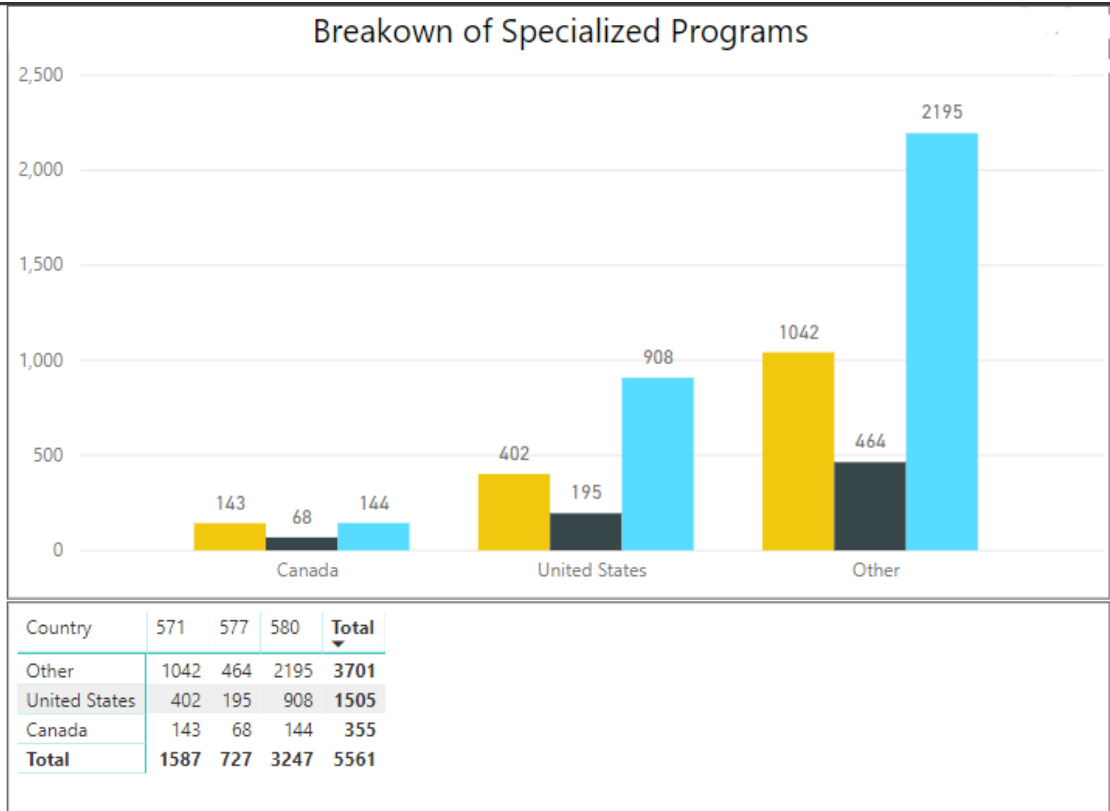
Overtime we have seen an increase in interest from other countries grow in our certification programs from countries outside the US. We continue to see growth in Canada due to the API 1169 program.

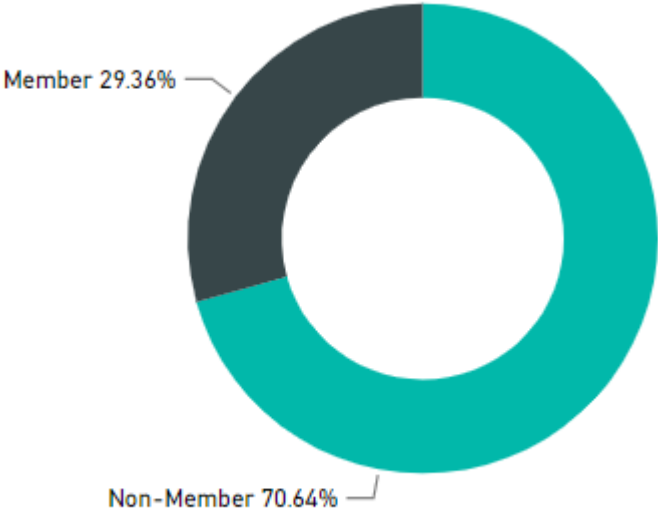
## Global Certificate Distribution (Total by Country)

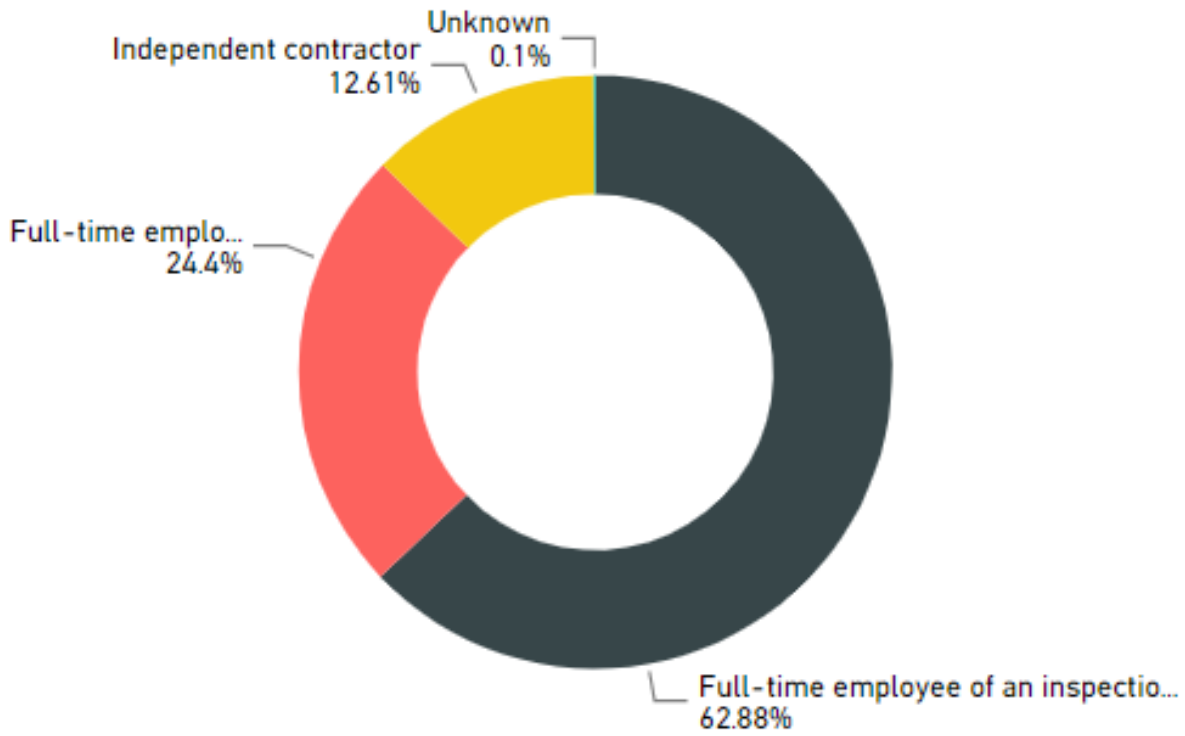

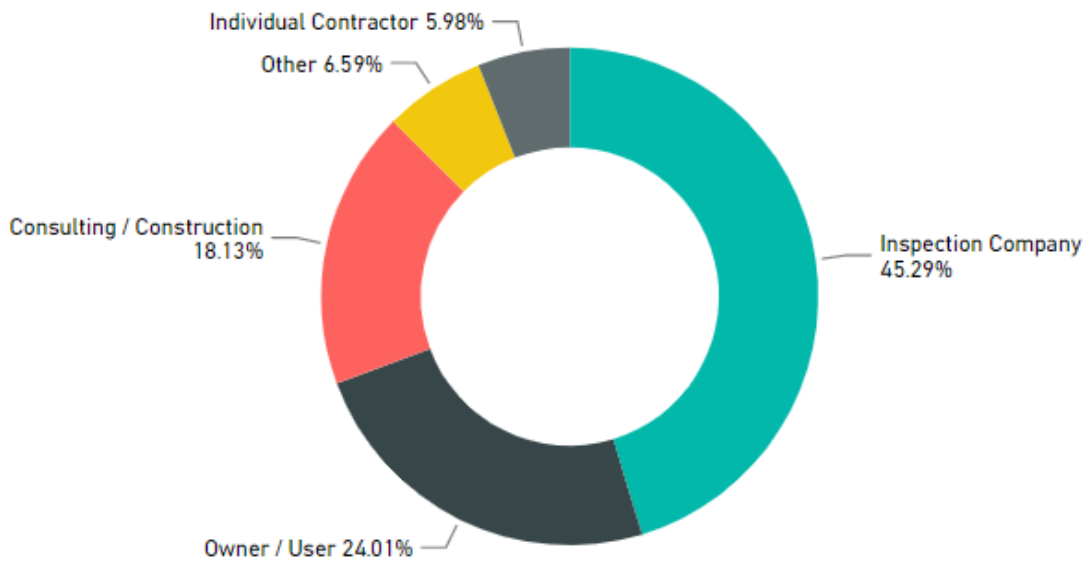


# Demographic Breakdown of Certified Inspectors

## Active Certified Inspectors by Employment Type

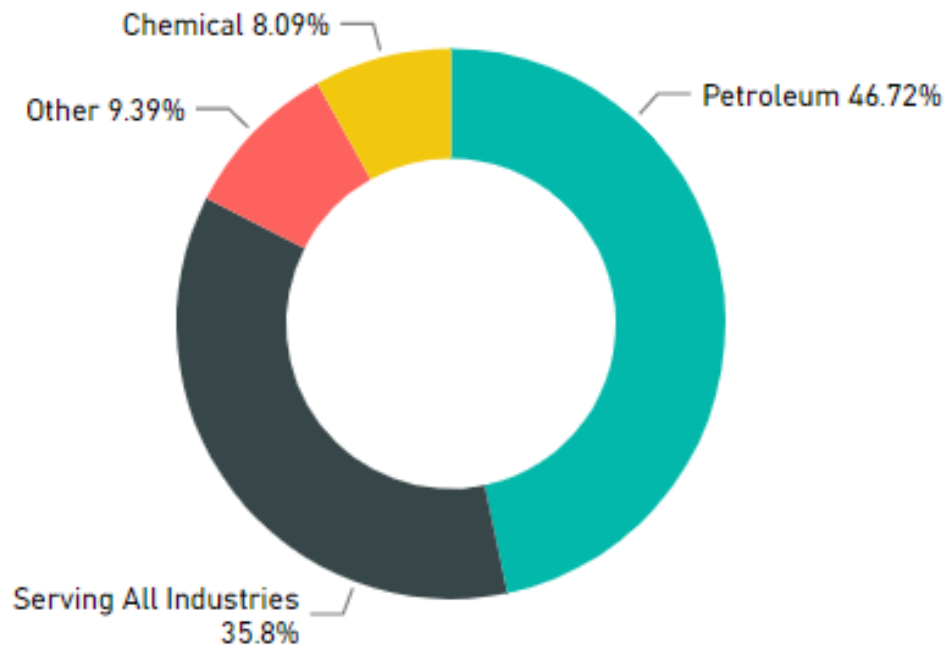


## Certified Individuals by Organization Type



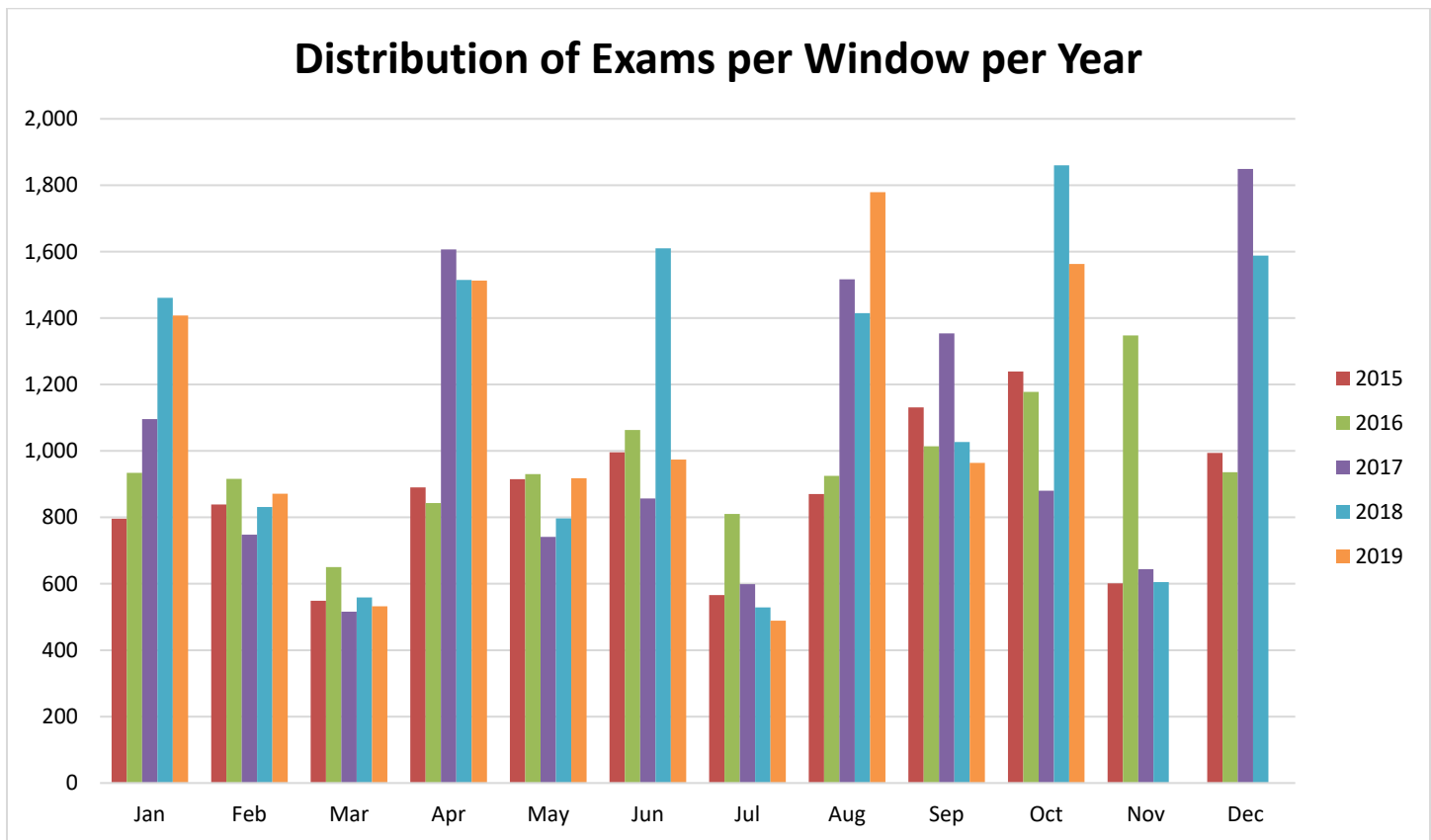

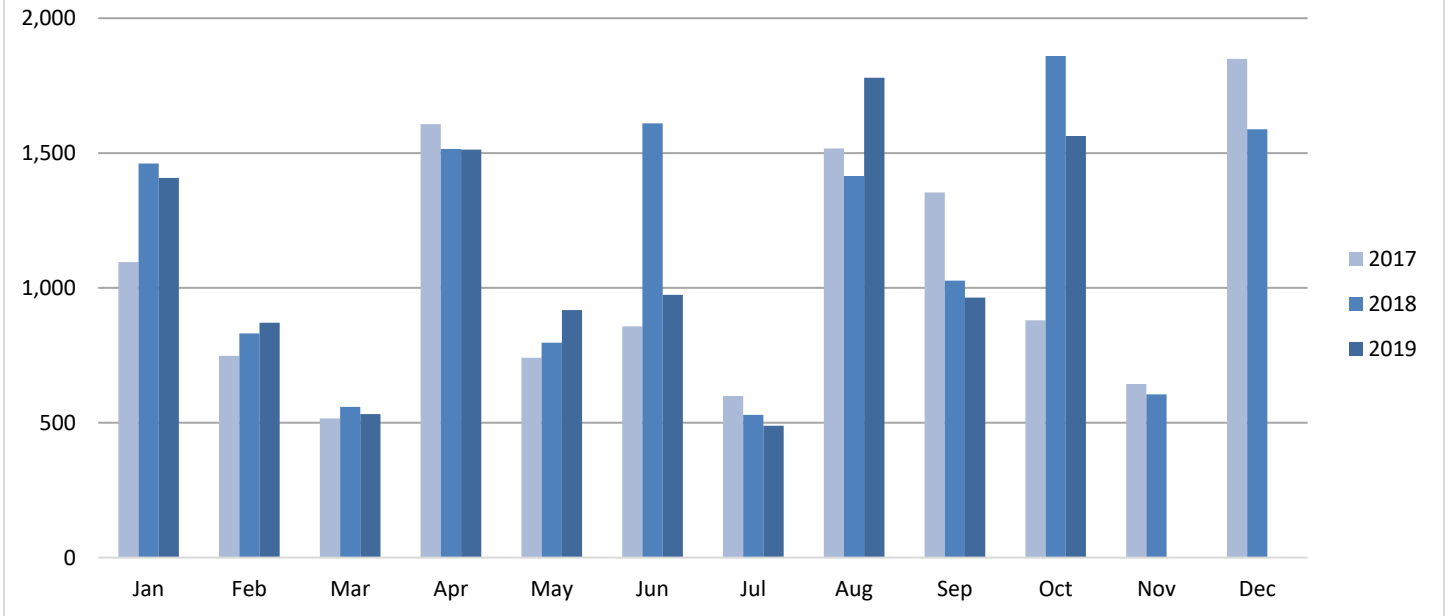

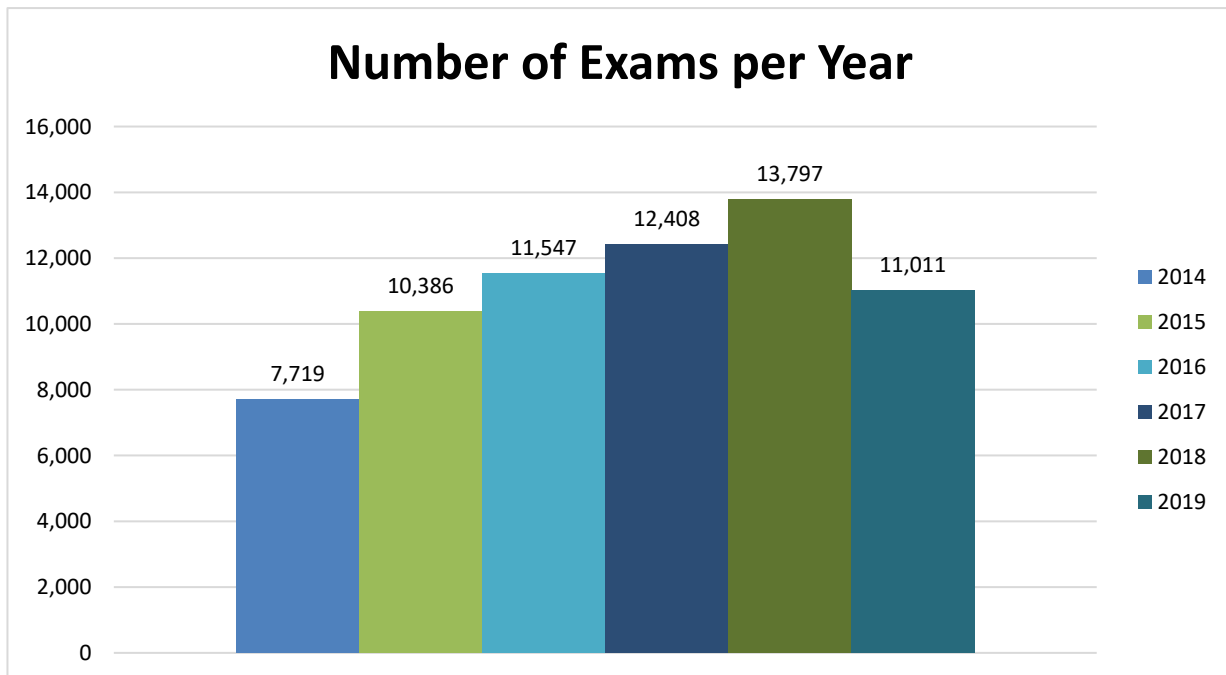

## Distribution of Exams per Window 2017 - 2019



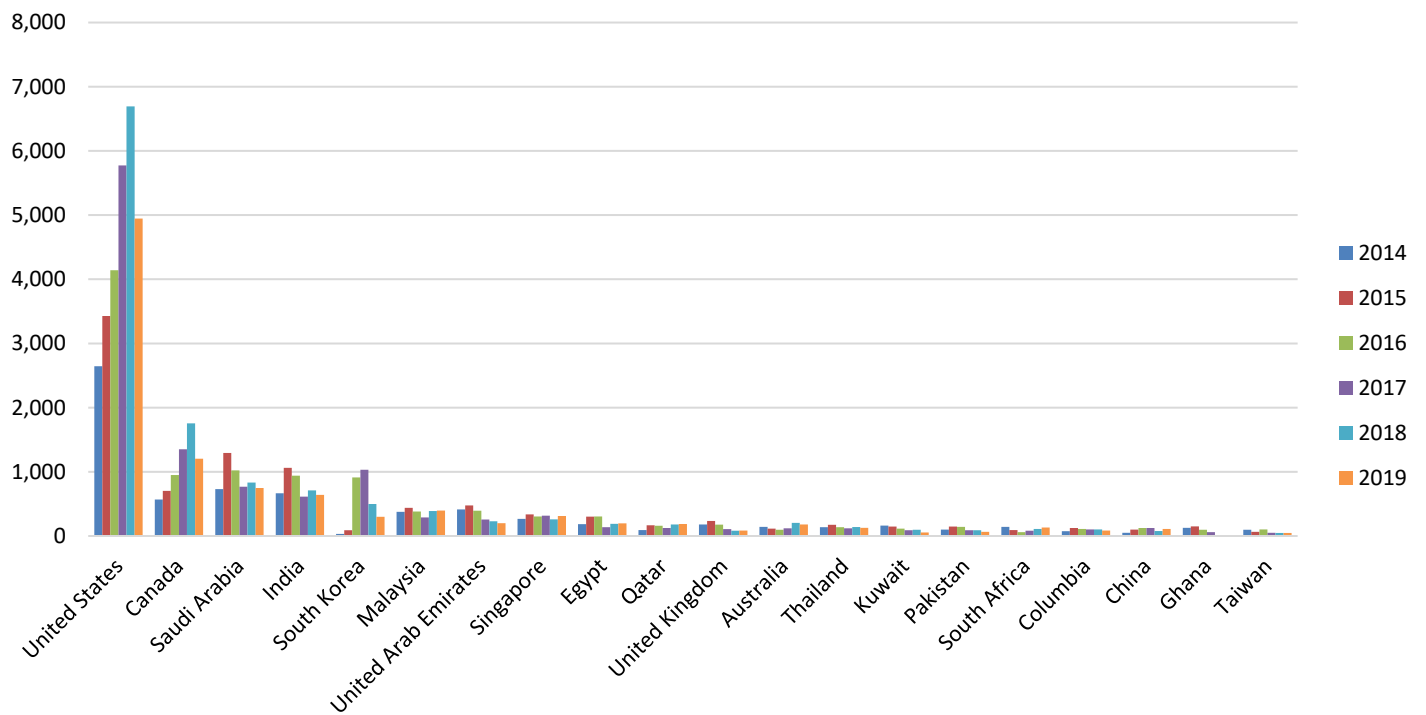

Between 2014 and October 2019, ICP administered 70,651 exams in 80 different countries. Of these 3,783 are paper-based and 66,868 are computer-based (CBT). We have utilized over 400 of the 500 Prometric testing centers around the world.

Above is a chart that shows the top 20 countries by growth since the introduction of computer-based testing centers in 2014. As you can see, over time, 61,833 (92.4%) of our exams were delivered in those top 20 countries.
