



Gasoline Taxes

January 1, 2022

NATIONWIDE

The nationwide average tax on gasoline is 57.09 cpg, up 0.50 cpg from the July 2021 study. A summary of federal and state excise taxes and other taxes collected on gasoline is shown below. The federal tax on gasoline is 18.40 cpg. The average state gasoline excise tax is 26.16, up .19 from the July 2021 study. Other taxes (such as applicable sales taxes, gross receipts taxes, oil inspection fees, county and local taxes, underground storage tank fees and other miscellaneous environmental fees) were 12.53, up 0.31 cpg from the July 2021 study. Adding these taxes and fees to the state excise taxes results in a volume-weighted average state and local tax of 38.69 cpg.

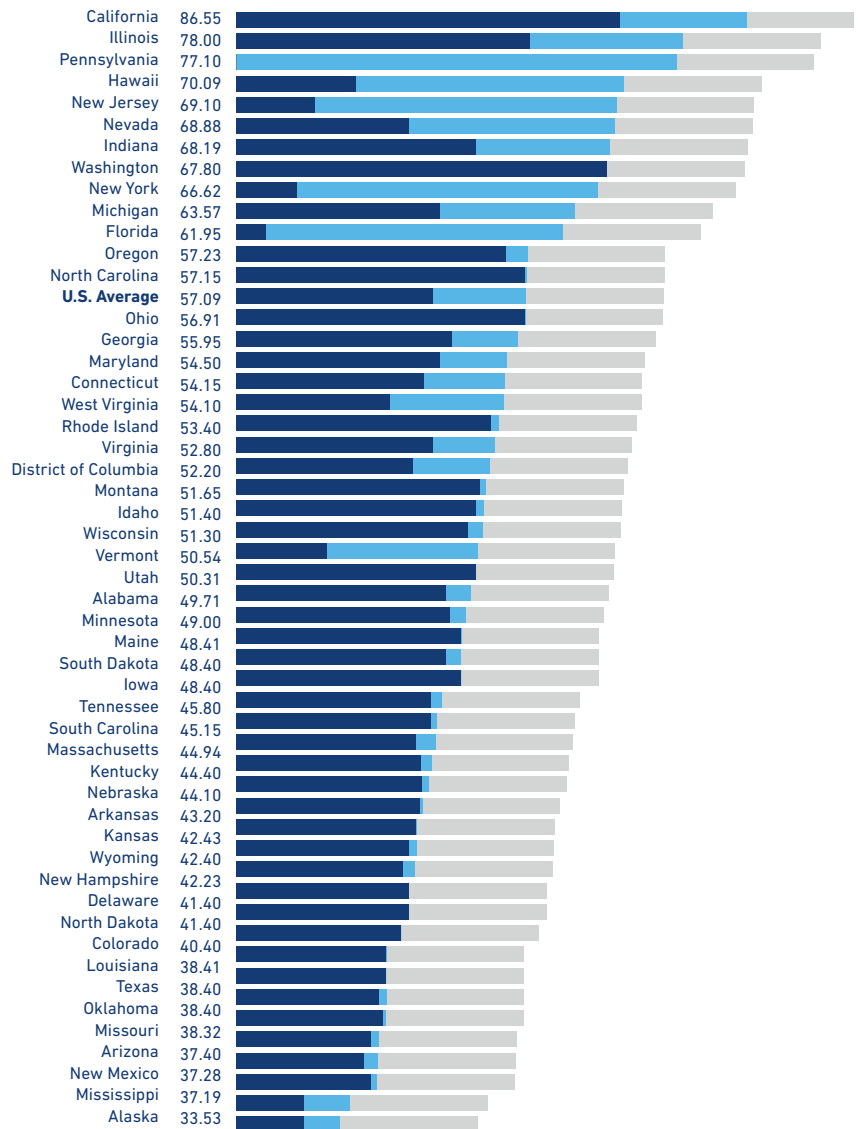

The nationwide average tax on motor diesel fuel is 64.64 cpg, up 0.97 cpg from the July 2021 study. A summary of federal and state excise taxes and other taxes collected on diesel is shown below. The federal tax on diesel is 24.4 cpg. The average state diesel fuel excise tax was 26.72 cpg, up 0.16 cpg from the July 2021 study. Other state and local taxes average 13.52 cpg, up 0.81 from the July 2021 study. These other taxes include applicable sales taxes, gross receipts taxes, oil inspection fees, county and local taxes, underground storage tank fees and other miscellaneous environmental fees. Adding these taxes and fees to the state excise taxes results in an average state and local tax of 40.24 cpg.

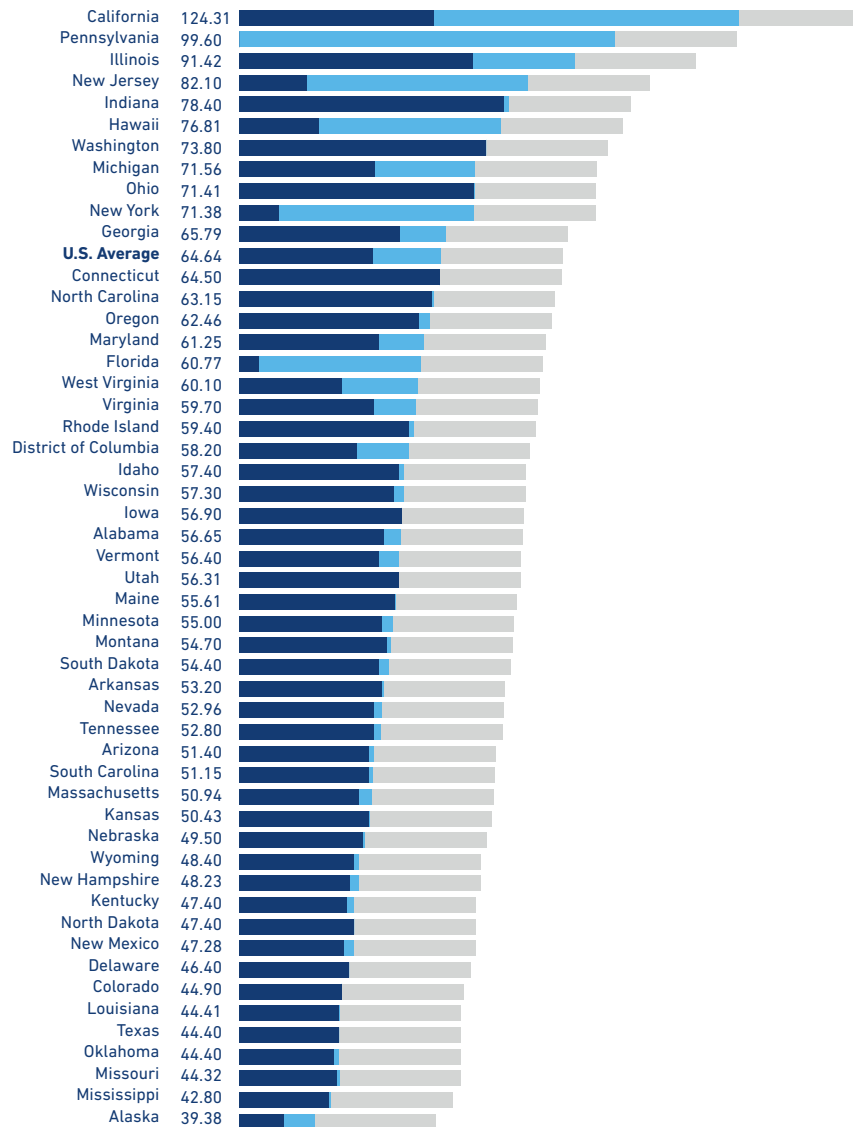
